### Advisory on Travel Plans and Health Protocol for Students

- 1. All students should continue to defer all travel overseas unless it is permissible under the prevailing MOH's travel advisory. Please note the following points for consideration if you are making any travel plans for your child/ward.
  - a) Students and parents must update the school of their plans to travel to countries/regions approved in the MOH travel advisory (please refer to Immigration and Checkpoints Authority (ICA) website [https://safetravel.ica.gov.sg] for details);
  - Actual time spent overseas will be limited since travellers need to adhere to Singapore's requirements for entry (e.g. time to serve SHN) as well as travel requirements in the country of travel;
  - c) Stay-Home Notice (SHN) may be issued upon return to Singapore and will be chargeable at an SHN Dedicated Facility (refer to official website [https://safetravel.ica.gov.sg/sc-pr/requirements-and-process] for updated list of countries, where individuals would have to serve SHN at dedicated facilities);
  - d) Individuals might need to bear the cost of mandatory travel insurance and unsubsidised healthcare for COVID-19 treatment in case of infection upon return, if applicable;
  - e) In case of changes in travel restrictions by Singapore or other countries, there is a risk that students may not be able to return in time for the start of the school Term.
  - f) International Students (Student's Pass/ Dependent's Pass holders) and their accompanying family members (if eligible) are required to apply for and obtain entry approval from the Safe Travel Office (STO) to re-enter Singapore;
    - i. Student's Pass (STP) Holders are to obtain approval via the SafeTravel application portal (<a href="https://eservices.ica.gov.sg/STO">https://eservices.ica.gov.sg/STO</a>) at least two weeks before their intended travel date, and up to five weeks in advance.
    - ii. Dependent's Pass (DP) holders are to obtain entry approval from MOM through their parent's/guardian's employer.
    - iii. For new entry applications, travellers should note that entry approvals have been reduced for travellers with a travel history to all higher-risk countries/regions, except for those in Category I and II in the table on this page (https://safetravel.ica.gov.sg/stpl/shn-and-swab-summary)
    - Travellers who are unable to secure their desired period of entry in the SafeTravel application portal are advised to check for new entry periods the following week, or defer their travels until the situation has stabilised.
    - v. STP holders are advised to check the SafeTravel website (<a href="https://safetravel.ica.gov.sg/stpl/requirements-and-process">https://safetravel.ica.gov.sg/stpl/requirements-and-process</a>) for the most updated border measures, as well as requirements and processes for entry application. DP holders may check <a href="https://safetravel.ica.gov.sg/wphl/overview">https://safetravel.ica.gov.sg/wphl/overview</a>. If assistance is required, they may also call the SafeTravel Enquiries Helpline at 6812 5555, or write in to <a href="https://go.gov.sg/sto-enquiry">https://go.gov.sg/sto-enquiry</a>.
  - 2. Border measures, health protocol and requirements for entry may change over time depending on the public health situation in the respective countries. Please check on these requirements by visiting the SafeTravel website at [https://safetravel.ica.gov.sg] and the Ministry of Health (MOH) at [https://www.moh.gov.sg/covid-19
